

This Delinquent tax list is published in accordance with Utah Code 59-2-1332.5. The listed Taxpayers became delinquent after December 2, 2019. As of December 3rd a penalty of \$10.00 or 1.00% of the unpaid tax, whichever is greater, was charged on EACH delinquent parcel, but does **NOT** appear in the total on the list. If tax and penalty are not paid on or before January 31, 2020, the penalty will be increased to 2.5% and interest will be applied on a daily basis at 8.45% per annum from January 1, 2020 through the date the payment is processed in our office. Unfortunately, we can not be responsible for lost or delayed mail. Payment can be made by check to the address below or you can find instructions to pay through your bank or a credit card at www.daggettcounty.org/taxes .
