

DAGGETT COUNTY RESOLUTION 19-17

A RESOLUTION REGARDING THE WEED DEPARTMENT'S EXCLUSIVE USE OF THE WEED DEPARTMENT TRUCK AND SHOP SPACE

WHEREAS, the funding for the Daggett County Weed Department is, in part, obtained through grants which have specific conditions on how said funding is to be used; and

WHEREAS, the Weed Department was in need of a vehicle in order to perform their duties and control noxious weeds in the County; and

WHEREAS, the funds received by Daggett County Road Department also contain specific conditions pursuant to Utah Code on how those funds are to be used; and

WHEREAS, the Daggett County Road Department had a 2004 Dodge 2500 Regular Cab SLT which was no longer needed for the operation of the Road Department; and

WHEREAS, the Weed Department was also in need of a place to store the vehicle and other Weed Department equipment; and

WHEREAS, the Road Department facilities has shop space that is not needed for the operation of the Road Department; and

WHEREAS, the Board of County Commissioners of Daggett County approved a motion to surplus the 2004 Dodge 2500 Regular Cab SLT which was owned by the Road Department, with the intention of leasing the truck to the Weed Department for a period of 4 years, with the first payment being due in the fiscal year 2017. The Weed Department would then pay for the lease out of the Weed Department fund the amount of \$4,000.00 for the first 3 years of the lease, and \$3,000.00 for the fourth and final year of the lease; and

WHEREAS, the Weed Department agreed to lease the shop space from the Road Department for an annual lease payment of \$3,600.00 per year; and

WHEREAS, in order to ensure the conditions on the funds of the respective departments are met, the Weed Department would write a check and full transparency would be put in place so that the funds can be easily tracked and accounted for; and

WHEREAS, The Board of County Commissioners has determined that this Resolution is in the best interest of the citizens of Daggett County to promote the public health safety and welfare of the citizens of Daggett County.

NOW THEREFORE, be it hereby resolved by the County Legislative Body of Daggett County as follows:


1. Pursuant to the lease agreement approved by the Daggett County Board of Commissioners, enumerated in the minutes of the Daggett County Commission meetings, and beginning in the fiscal year 2017, the Weed Department has the exclusive right to use the 2004 Dodge 2500 regular cab SLT, VIN # 3D7KU26C24G193883.

2. The Daggett County Weed Department also has the exclusive right to use the agreed upon shop space in the Road Department facilities in exchange for its annual payment of \$3,600.00.

3. In order to avoid confusion and ensure restricted funds are used properly, the accounting for the lease payments shall be tracked and fully transparent.


