

Resolution 18-21

A RESOLUTION CLARIFYING CURRENT DUTCH JOHN UTILITY WATER AND SEWER RATES AND POLICIES

WHEREAS, Daggett County established certain rates for water and sewer hookups in the Dutch John Area on March 6, 2001; and

WHEREAS, on May 19, 2015 the Daggett County Commission passed and adopted Resolution 15-16, a resolution amending Dutch John water and sewer rates; and

WHEREAS, on October 30, 2018 the Daggett County Commission passed and adopted Resolution 18-17, a resolution clarifying current Dutch John utility water and sewer rates and policies, however, the policy regarding reconnection fees was inadvertently left out of the resolution; and

WHEREAS, review of these rates reflect some confusion as to how the rates are applied and how they are currently being calculated; and

WHEREAS, the current policies regarding payment of rates, late fees, reconnection fees, shut-off notices in the event of failure to timely pay, etc., need to be clarified and or updated.

NOW THEREFORE, be it hereby resolved by the Board of County Commissioners of Daggett County that the following established monthly rates and policies be clarified for the users of the Daggett County - Dutch John Water System:

- Residential Water:** 0 gal to 12,000 gal, - \$76.98 Basic
12,000 gal to 20,000 gal, - \$2.00/1000 gal
20,000 gal and above \$2.50/1000 gal
- Commercial Water:** 0 gal to 12,000 gal, - \$115.47 Basic
12,000 gal to 20,000 gal - \$2.00/1000 gal
20,000 gal and above - \$2.50/1000 gal
- Residential Sewer:** \$37.50 for each unit
- Commercial Sewer:** \$56.75 for each unit with a 4 inch connection
\$75.00 for each unit with connection larger than 4 inches

Multiple units: (Hotels, Motels, RV parks, Etc.)
Commercial rate plus 1/4 the commercial rate for each additional unit or site. Multiple unit charges are applicable only to Commercial Water rates.

Communal Restroom Facility: Commercial rate plus 1/6 the commercial rate for each unit that utilizes the facility. Communal Restroom Facility Charges are applicable only to Commercial Water rates.

Unit: A "Unit" is defined as one room, cabin, or space in a hotel, motel, RV park, etc.

Late Payment Policy: Payment is due on the last day of each month. If payment has not been received by the last day of the month, a late fee in the amount of \$20.00 will be assessed.

Shut-off Policy: If an account has been delinquent, meaning not paid in full, for a period of two months, the users water will be shut-off. Notice of the potential shut-off will be provided on the first bill in which the payment becomes delinquent. No further notice shall be provided.

Reconnection: Any service disconnected for any reason, either voluntarily or for non-payment, shall remain disconnected until all delinquent amounts have been paid in full, as well as an amount equivalent to six times the monthly base rate.

Effective Date: this Resolution shall become effective upon signature of the Chair of the Daggett County Board of Commissioners.
