Turkey Release: Sheep Creek Canyon

Sheep Creek Canyon near Flaming Gorge has 20 new residents, Merriam's wild turkeys released by the Utah Division of Wildlife Resources. The turkeys were from wild flocks trapped in the Bonners Ferry area of Northern Idaho near the Canadian Boarder. Members from the National Wild Turkey Federation assisted Division biologists with the long drive to Northeastern Utah.

Biologists hope to establish a population of Merriam's Turkeys along the bench above Flaming Gorge Reservoir and the eastern Uinta Mountains. This subspecies was chosen because it prefers more mountain habitats with forests of Ponderosa Pine, interspersed with Aspen, Pinyon-Juniper, Gambels Oak and other mountain shrubs, grasses and wet meadows. Grasshoppers and other insects, nuts, seeds, and green vegetation are important food items. The Rio Grande subspecies is more of a riparian species preferring the cottonwoods, willows and other vegetation found along larger rivers.

Steve Radosevich was honored by friends and family for his 100th birthday, at an open house on December 2, 2006 in Rock Springs, Wyoming. Nearly 300 people gathered at the Outlaw Inn to help Steve celebrate. Guest related stories of the good times spent with Steve and his great granddaughter Cheyenne Reid read the poem that she had written for Grandpa Steve.

On December 5th 1906, Steve Radosevich was born in Gallup, New Mexico, the son of George and Mary Radosevich. The family moved to Rock Springs in 1911. His parents owned and operated the Yellowstone Grocery and cabins in Blair Town. It was there that Radosevich met his wife Arlie Teters.

He attended schools in Rock Springs through the eighth grade and then went to work in the coal mines. He later was employed part time by Wyoming Game and Fish for 10 years and then by Utah Fish and Game as a game warden while living on the ranch in Browns Park. He and his wife Arlie continued to live at the ranch in Browns Park until her passing in 2002. He has recently gone to stay with his daughter in Star Valley.

Steve and Arlie raised four children at the ranch in Browns Park. Their four children and spouses are Mary Lou Moser and husband Carl of Star Valley, Georgann Besso and husband Chuck of Star Valley, Don Lindsley and wife Carma of Granger and Alex Radosevich and wife Joan of Browns Park. Their 13 grandchildren, 33 great grand children and 18 great-great grand children still love to visit grandpa at the ranch.

Reopening of the Clinic

TriCounty Health Department owns a health clinic that it has been trying to re-open. During the Primary Election in 2006, voters passed a resolution allowing the Commission to charge a sales tax of up to 1% that can only be used for the clinic and emergency medical services. Current plans are to reopen the clinic in the spring or summer of 2007. The Clinic is scheduled to be open 4 days per week.

Current Services Offered

TriCounty Health Department currently offers dental services and a health nurse. The dentist, Dr Giauque (pronounced Juke), visits the Clinic once a month and can be contacted for an appointment at (800) 400-1456. The TriCounty Health Nurse visits every other Wednesday between 10 and 11:30 am and 1 to 3 pm.

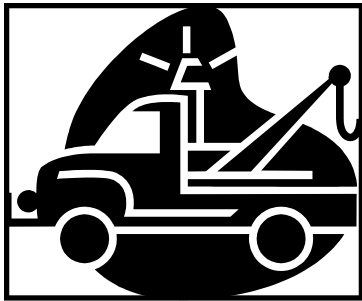

Firefighters Combat House Fire

Firefighters from Manila, Utah, Green River, Wyoming and Sweetwater County all responded to a structure fire on December 10th, 2006, just across the Utah/Wyoming border.

According to Lt. Peter Butcher of the Manila Fire Department, said on December 10th at 11:33 a.m., the Manila Fire Department was dispatched to a structure fire in Washam. The first units arrived in three minutes to a fully-engulfed home.

Butcher said the fire was believed to be started by a hot water heater. The fire was reported when an unknown person knocked on the door of the Magana family home located a quarter of a mile away from the Jarvie residence. Adan Magana dialed 911, handed the phone to a bystander and sprinted to the burning home to offer assistance.

Two elderly female residents, Ruth and Pam Jarvie, were inside and refused to leave. Neighbor Magana and Keith Larsen carried out the women before firefighters arrived.

Magana then went back into the structure for Pam Jarvie's wheelchair.

The Green River Fire Department responded from 55 miles away with six firefighters to assist. Sweetwater County firefighters came from 70 miles away with a tanker and three firefighters.

Manila had 11 firefighters respond with four apparatus.

Officials said that the home and all of its contents were deemed a complete loss.

DROUGHT DISASTER DECLARATION ISSUED FOR DAGGETT COUNTY

Despite an adequate water year for most of the State of Utah, Daggett County was not so fortunate and has qualified for a state drought disaster declaration. Utah Commissioner of Agriculture and Food, Leonard Blackham asked for, and received the declaration from Governor Huntsman following severe drought conditions that caused an estimated \$900,000 in damage, in the form of lost crop revenue to farmers and ranchers.

In a letter to U.S. Secretary of Agriculture, Mike Johanns, requesting a federal disaster declaration and assistance, Governor Huntsman stated, "This is the smallest rural county in our State and this type of financial impact on the farming and ranching community has had and will continue to have a devastating effect on the overall economy of this area."

The drought has also severely affected range and pasture conditions resulting in serious losses to those producers.

U.S. Agriculture Secretary Johanns will review the request and could act within the next few weeks. Possible aid for farmers and ranchers would come in the form of low-interest loans.

Public Hearing Held

On Thursday, December 28th, 2006 the Daggett County Commissioners and the Town of Manila held a combined Public Hearing. The issue was to determine the desire for the Town of Manila to join the Daggett County Road and Transportation Special Service District. The Commission Chambers were packed as residents came to see what this proposal would mean.

The Road and Transportation Special Service District is a non-taxing Special Service District that receives no tax dollars, but does receive mineral lease monies. These monies are generated by oil and natural gas extraction and are used to pay for special road improvement projects within the district. The Special Service District is separate from the County Road Department, but works with the road Department staff to complete road improvement projects. The Special Service District can not give money directly to the Town of Manila, but can work with them, supply labor, equipment and materials to complete projects within the Town if they become a part of the District. There is still a 15-30 day period where this can be contested, after which resolutions by the Town and the County will be created and passed to finalize the process.

During the Meeting it was mentioned that The County Road Department and the Town of Manila both receive Road money generated by State Fuel Taxes based on the types of roads (paved, gravel, and dirt) and the distances of each. Both entities receive these maintenance monies based on different formulas created by the State of Utah. These monies are barely enough for maintenance of the roads and do not allow for improvements or upgrades, which is where the Special Service District can help.
