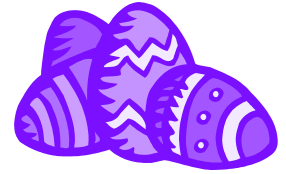

MANILA FFA CHAPTER ATTENDS STATE CONVENTION

Members of the Manila FFA Chapter attended the Utah State FFA Convention March 22-24, at Utah State University. Members participated in many contests and events while at the convention.

Chapter members won eleven state proficiency awards. Winners included: Ashley Straatman, in Agricultural Communications; Casey Robinson, in Agricultural Processing; Camille Rose, in Agricultural Sales; Kodee Schell, in Beef Production Placement; Karlee Schell, in Diversified Livestock Production Placement; Lacy Larsen, in Equine Production; Nina Beck, in Forest Management; Taylor Reed, in Home and Community Development; Casity Muggelberg in Outdoor Recreation; Michael Hughes, in Swine Production; and Kim Northcott, in Turfgrass Management. Each award winner received a plaque and a check for \$250, and the right to compete at the National FFA Convention.

Thirteen members of the chapter were presented the State FFA Degree. These members included Nina Beck, Jeff Gosar, Kali Hughes, Lacy Larsen, Adan Magana, Natasha McCullough, Angel Morton, Casity Muggelberg, Kimberly Northcott, Taylor Reed, Karlee Schell, Kodee Schell and Ashley Straatman.

Kodee Schell was also named the Star State FFA Degree recipient in Placement, Lacy Larsen was the First Runner-up to the Star State Award in Agriculture Production, and Kim Northcott was the First Runner-up in Business. Chantz Potter was named the Second Runner-up in the State Star Greenhand in Agriculture Production and Jake Martin was Second Runner-up to the Star State Greenhand in Placement. All star recipients received a plaque and cash award. Michael Hughes, Autumn Hullinger, Casey Robinson, Camille Rose and Calvin Schell were also recognized as American FFA Degree candidates. Karlee Schell was awarded the Agri-Entrepreneurship Award, which includes a certificate and \$100 from the Ewing-Kauffman Foundation.

In other contests, Karlee Schell reached the finals in the Job Interview career development event. Kelsey Lynch was a finalist in the Creed Speaking Contest and placed fourth overall, and Alle Muir also participated. Chantz Potter competed in the Prepared Public Speaking contest, and Blake Olorenshaw in the Extemporaneous Public Speaking Contest. The Parliamentary Procedure Team composed of Ashley Straatman, Lacy Larsen, Kodee Schell, Blake Olorenshaw, Nina Beck and Angel Morton also competed. Delegates for the convention were Jordan Catron and Kali Hughes. Serving on the Courtesy Corps was Amy Stevenson. Blake Olorenshaw was a member of the state officer nominating committee, and Ashley Straatman was a State Officer Candidate.

The chapter was awarded the Superior Chapter and Five Star Chapter Awards. Chapter members received over \$4000 in cash awards.

At the conclusion of the convention, Camille Rose retired as the 2005-2006 Utah State FFA Association Secretary. Other members in attendance included Kylee Ellsworth, Breeana Asay, Nathan Beck, Ashley Bills, Lysnie Slaugh, Jessica Gosar, Steele Muggelberg, Justin Olsen, Jared Reed, Luke Slagowski and Colter Smith.

Highlights of the Manila-Washam Salinity Project

Following the release of the Environmental Assessment, USDA-NRCS accepted salinity applications in the Manila-Washam watershed area for fiscal year 2007. Over 25 producers requested in excess of \$3 million of cost share assistance. Due to the large demand for assistance, NRCS will be opening a satellite office in Manila, provided by the county, to accomplish the large task. In addition to the office, NRCS detailed 3 employees from Wyoming in addition to the Vernal staff. These employees will work in Manila through the middle of May as needed.

UGIP - Utah Grazing Improvement Program

The UGIP was established by House Bill 145 during the 2006 Legislative session. It passed unopposed and was signed by Governor Huntsman. HB 145 established regional grazing boards, a State grazing board and allows UDAF to award grants for rangeland improvements and invasive plant control. The legislature approved \$2,000,000.00 for 2007.

The intent of the Bill is to give ranchers an opportunity to express their grazing concerns and needs, aid the ranchers in communicating their concerns to the BLM, US Forest Service, EPA and other federal and state agencies. Cost-share grants are being made available to ranchers for rangeland improvements, such as: invasive plant species control, improve water quality and quantity, replace juniper and sagebrush with high quality grasses and increase rangeland productivity.



Cricket/Grasshoppers

Worried about the possible infestation of grasshoppers & crickets this year? Effective control must include large acreages, insects don't respect fences so it doesn't do much good to kill crickets or grasshoppers on your land if they will just move in from your neighbors. Landowners need to be organizing this winter in order to plan control efforts. Tax Time is Approaching

April 16th is this year's deadline for tax returns or payments to be filed. If you haven't filed your return yet, be sure to check to see if you qualify for the Telephone Tax Refund (TETR). The IRS's website explains that the TETR is a one-time payment available on your 2006 federal income tax return for previously collected long distance telephone taxes. The IRS offers a standard refund of \$30 to \$60, but you can also figure exactly how much has actually been paid. The refund is available for businesses, tax-exempt organizations as well as individuals. The IRS website at www.irs.gov has tips and information to help you determine if you qualify for this refund and how much you're eligible to be refunded.

Other helps and credits that are available include the Earned Income Tax Credit for those who earned less than \$39,000 in 2006 and IRS Free File for those earning less than \$52,000. For more information visit the IRS website at www.irs.gov!

Planting Bare Root Trees and Shrubs

Keep roots of bare root trees and shrubs moist and protected at all times prior to planting. Prepare planting hole for each plant before removing it from its protected, moist site.

Prepare a hole that is large enough to spread the roots without crowding. Rough the sides of the hole to be sure they are not glazed from digging, which would form a barrier for water and roots.

Inspect the roots of the plant. Prune away any broken or damaged roots.

Place the roots in the hole at a level so that the soil surface will be at the same level where the plant was previously growing, as indicated by the slightly darker area of the trunk. Trees should be planted so that the graft or trunk flare is 1" above the final soil surface. It often helps to form a mound or "cone" of soil on the bottom of the hole and spread the roots over the mound.

Backfill the soil into the hole a few inches at a time, firming the soil after each addition. While backfilling, be sure the plant remains vertical and be careful not to damage roots. Use water to settle the soil around the roots while backfilling. After backfilling is complete, form a ridge of soil around the edge of the hole to puddle and hold water around the plant.

Place 2 or 3 4-foot stakes around each tree approximately 10" from the trunk. Using a soft rope or tape made especially for tying trees, tie a piece of rope around the trunk to each stake. Be sure the rope being used will not injure the bark. Threading the rope through a short section of old garden hose can protect the tree bark. Stakes can be removed after the first growing season. It is not usually necessary to stake shrubs.

Thoroughly water the plant. Keep well watered until established. Mulching with wood chips or shredded bark helps retain moisture. Keep mulch 1-2 inches away from the plant's trunk to prevent damage from moisture. Do not over water. Allow the soil surface to dry to a depth of 1-2" between waterings.

Protect young, smooth-barked trees from sunscald by wrapping the trunks. This practice also protects young trees from rodent and rabbit damage.

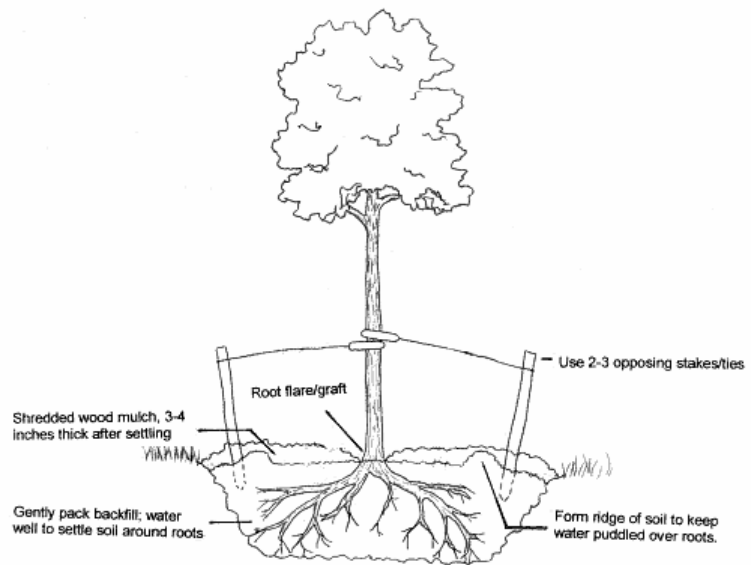

SPRING IS APPROACHING

As the weather turns warmer and the days get longer, our thoughts turn to those outside projects. If you are planning on doing any building or remodeling you will need to apply for a Building Permit.

Building Permits are required by the County prior to the start of construction. Building Permit Packets may be obtained at the Clerks office in the Courthouse, or by calling 435-784-3154.

Please check with the Planning and Zoning secretary, Kathy Padron, at 435-784-3993, on all set backs and Zoning regulations BEFORE submitting your Building Permit Packet and drawings.



Turn around time for approval of Building Permits will depend on how complete the packets are when they are returned. All plot maps MUST include measurements for all structures in relation to property boundaries and other buildings located on the property. Include all roads and driveways. Plans and drawings for proposed buildings must have a truss detail, which must include an Engineer's stamp, as well as all information concerning the footings and foundations. The more complete the information, the faster it will be to get your permit.

Renewable Energy and Energy Efficiency Grants

The United States Department of Agriculture's Rural Development Office has announced the deadline for grant and loan funding applications for Renewable Energy and Energy Efficiency projects. May 18th is the deadline for farmers, ranchers and rural small businesses to apply for up to 25% re-imbursement of a future project. July 2nd is the deadline for a 25% loan request or a combination of 25% loan and 25% grant application. The applications are fairly involved and require feasibility and environmental reviews, but if you have a project like this already in the planning stages, now is the time to get more information about this program. Information is available on the Rural Development website at <http://www.rurdev.usda.gov/rbs/farmbill/index.html> or by contacting Vern Anderson of the USDA Vernal Office at (435) 789-2100 ext. 19 or Brian Raymond at the Daggett County Economic Development Office at (435) 784-3218 ext. 134. This is an annual program, so if the current time frame is too tight, start preparing now for 2008.

Don F. Winter

Don F. Winter, of 660 Ironwood, Green River, died Sunday, March 11, 2007.

He was born in Salt Lake City on May 4, 1929, the son of Frank Albert and Gertrude Olga Amanda Holtz Winter. He graduated from South High in Salt Lake City.

Winter served in the U.S. Army. He graduated from the University of Utah with a degree in criminology and was a special investigator for the Utah Attorney Generals Office for seven years.

He started his first business at the age of 15 along with his cousin Ken shoveling and delivering coal to homes. He owned and operated 33 restaurants and bars including the Villa in Manila, Utah, and the Embers Restaurant and Clearview Bowling Center in Green River. He later purchased Fryberger Sand and Gravel in the late 1970s and created Gorge Sand and Gravel, Gorge Ready Mix, Gorge Construction and Gorge Auto Body and Glass. He bought Texs Travel Campground. Winters latest endeavor was the Winter Professional Building that is under construction.

In 2005, Winter was honored by the Wyoming Business Council when he and his wife received the Den Costantino Bravo Award for embodying the best entrepreneur traits.

His interests included enjoying the outdoors, hunting, snowmobiling, boating, four-wheeling taking long drives in the country and cars. He raced most classes at the Salt Lake Speedway and went on to race the Can-Am Circuit.

He is survived by his wife, Gaye Winter of Green River; children, Barry Winter and wife Lucinda of Vernal, Utah, Larry Winter and wife Val of Green River, Sherry Winter of Pocatello, Idaho, Brenda Strandlee and husband Curtis of Kingman, Ariz., Cindy Winter of Green River, Keith Winter and wife Jody of Toquerville, Utah, Shelly Smith and husband Robert of Grand Junction, Colo., Tracy Bernard and wife Connie of Green River, Daryl Winter and fianc Michele of Green River, Cory Bernard and wife Dawn of Green River, Delaina Smith and husband Arron of Green River, Lynn Winter of Salt Lake City, Josh and Donetta Winter of Green River and Cris Koumpan and wife Marilyn of Rock Springs; 42 grandchildren; and 23 great-grandchildren.

He was preceded in death by his parents; one half brother, Albert Winter; one son, Douglas Bernard; and granddaughter, Stacey Winter.

Funeral services were conducted at 2 p.m. Saturday, March 17, 2007, at the First Church of the Nazarene, 630 River View, Green River. Interment was held in the Riverview Cemetery

Steve V. Radosevich

STAR VALLEY Steve V. Radosevich, 100, died March 8, 2007, at The Inn at Deer Run Assisted Living in Star Valley, where he had been residing for about 2 weeks.

Radosevich was born Dec. 5, 1906, in Gallup, N.M., one of six children of George and Mary Radosevich. His family moved to Rock Springs in 1911 where they owned and operated the Yellowstone Groc. and cabins in Blairtown.

There he met and married, Arlie Teters, his bride of 75 years.

He attended school in Rock Springs, but spent most of his time at the stockyard in Blairtown. His father said he graduated from the stockyard in eighth grade and went to work, tending mine horses for the Blairtown mine. During the Depression, his father purchased the Willow Creek Ranch in Browns Park, Utah, and Radosevich and his family moved out there to operate it. After his fathers death, he purchased the Ranch from his siblings.

He worked from time to time for Wyoming Game and Fish. He later worked for Utah Fish and Game for 10 years. He received many awards and citations for his public relations role for the state.

His interests included hosting many festive occasions at his home, hard work and people.

He is survived by his three children, Alex and wife Joan of Willow Creek Ranch in Browns Park, and Mary Lou Moser and husband Carl, with whom he lived for the last two years, and Georgann Besso and husband Chuck, all of Star Valley; one foster son, Donald Lindsley and wife Carma of Granger; 13 grandchildren; 33 great-grandchildren; 18 great-great-grandchildren; and several nieces and nephews.

Pallbearers will include Michael and Zane Radosevich, Ron Besso, Don Lindsley, Philip Hardy and Bill Kunkel.

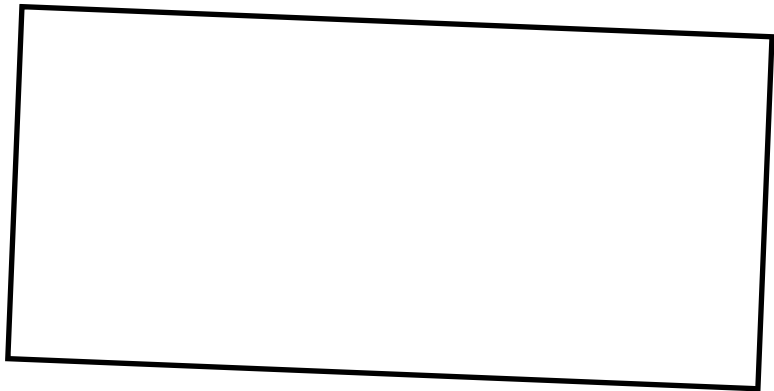
