Daggett County Residents EARLY VOTING

To participate in early voting you must be a Registered Voter by October 4, 2010 and you must bring a picture ID (valid drivers license) when you register and when you go to cast your vote. Voter Registration forms are available at both Manila and Dutch John post offices and also at the County Clerk's Office. Early voting will take place at the Daggett County Courthouse, 95 N 100 W, Manila, Utah beginning Tuesday, October 19, 2010 through Friday, October 22, 2010 and Monday, October 25, 2010 through Friday, October 29, 2010. The times for early voting will be 9:00 AM – 12:00 PM and 1:00 PM – 5:00 PM. The County Clerk's office will be open until 7:00 PM, only on Thursday, October 28, 2010. Early voting will also take place at the Dutch John Conference Hall, 530 S. Blvd., Dutch John, Utah on Wednesday, October 27, 2010 from 2:00 PM to 6:00 PM.

Remember, the last day to register to vote **by mail** is October 4, 2010 but you can still register to vote **in person** at the County Clerk's Office until October 18, 2010 until 5:00 PM.





- 5. Proof of medical expenses you paid out in September of 2010.
- 6. Proof of any child support and/or alimony you paid out in September 2010
- 7. Proof of disability (if applicable).
- 8. Proof of a child/children in the home age five (5) and under (birth certificate, etc.)
- 9. Additional documentation may be required.


