Daggett County Search and Rescue

At the Daggett County Search and Rescue meeting held January 8, 2007 Sheriff Rick Ellsworth and Utah State Commander Winston Slaugh congratulated Paulette Welder and present to her a plaque for 20 years of Volunteer Service to the Daggett County Search and Rescue. Paulette has been the Commander for the Search and Rescue for the last 2 years. Paulette works for the U. S. Forest Service in the Manila District.



Paulette started her search and rescue career with the U S Forest Service when they were called to look for lost persons on the forest. She started her Daggett County Search and Rescue career over 20 years ago and is the only Daggett County Search and Rescue member to have sustained 20 years of membership.

Paulette has donated thousands of hours of volunteer time on searches, both land and water. She has participated at the Parade of Lights to assist with traffic control each and every year. Paulette has worked hard at every fund raiser held by search and rescue and assisted in bring in thousands of dollars to assist the search and rescue in purchasing equipment. Paulette assisted other members of search and rescue in hosting the first Utah State Search and Rescue Membership Board Meeting held in May 1999 and the first Utah State Convention ever held in Daggett County in 2000.

Paulette is truly a cornerstone of the Daggett County Search and Rescue and should be congratulated for her many years of dedicated service.

Manila High School Sponsors Food Drive

Members of the Manila High School student body recently conducted a food drive to collect items for the Daggett County Food Pantry. More than two thousand items of food were collected in the drive.

The chief contributors to the effort were Mrs. Mosely's Seventh and Eighth Grade English classes. 1,973 different items were collected between the classes in a competition won by the seventh grade. Members of the student council delivered the items and then sponsored another drive, where spectators were given a dollar off for every food item brought to the Uintah River girl's basketball game. This event gathered another 136 items.

The students also had a competition won by the Eighth Grade to raise money for Sub-For-Santa. \$282.57 was collected and delivered to the local program. The student council would like to thank everyone who participated in the drives.

Neighbors Helping Neighbors

Isn't that the way we do business? When the cry for help, help comes; we drop what we're doing and we respond to help those in need. Many changes have occurred in the way responders do business since 9/11. Daggett County, Utah and Sweetwater County, Wyoming along with industry have teamed together to train, respond, and develop Interstate Mutual Aid Agreements then exercise all that has been done.



September 21, 2006 begins early for the responders and industry of these two counties as a full scale disaster exercise unfolds. There are injured victims trapped in vehicles along with other events that create an environment requiring more responders from the closest community which is Rock Springs in Sweetwater County, Wyoming.

The Daggett County Sheriff's Office, Daggett County Emergency Management along with the Daggett County Medical Services, Fire Departments, and Town of Manila, held a joint terrorist exercise in northeast Utah on September 21st. Daggett County was supported by Sweetwater Bomb Squad



(representatives from Green River and Rock Springs Police Departments and Sweetwater County Sheriff's Office); Sweetwater County Emergency Management; Sweetwater County Dispatch, Communication Technology from Rock Springs; Utah Department of Public Safety; Air Med; Utah Highway Patrol; Uintah Basin Consolidated Dispatch Center; Vase Ambulance Service from Sweetwater County; Castle Rock Ambulance from Green River, Gold Cross Ambulance from Uintah County; Utah Department of Homeland Security and Wyoming Department of

Homeland Security along with several private industrial companies which operate in Daggett and Sweetwater County, Salt Lake Chapter of the American Red Cross and multiple volunteers.



Homeland Security Presidential Directive 5 requires the use of the National Incident Management System and development of Incident Action Plans as well as activation of the tools needed in the Incident Command System. The responders in the communities in these two counties came together to develop the Incident Action Plan that helped them manage the incident. Additional resources were requested through their respective Emergency Management offices. Both State Homeland Security offices were notified of the incident through the respective Emergency Management offices.



The exercise was designed to judge the abilities of Daggett County and Sweetwater County to respond to a terrorist event and test the capabilities of inter jurisdictional cooperation and communication between agencies and distant dispatch centers. The event also gave Daggett County and Sweetwater County the opportunity to test and exercise the equipment it has received from Homeland Security grants.

Lessons learned from all the training that has occurred between the two counties over the past year have been beneficial toward enabling all involved to process through the proper steps as outlined through the National Incident Management System and the National Response Plan. The exercise culminated with measurable projects that need to be worked on to help both entities be ready for their next event whether it be an exercise or actual incident.

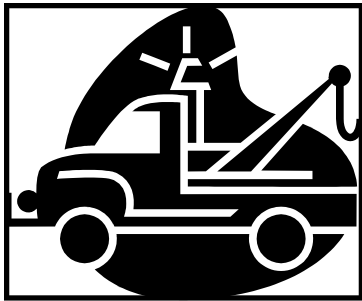

Daggett County General Plan Revision

Daggett County announces its intention to update its County General Plan and the Dutch John General Plan. The County has contracted with Aspen Rivers, LLC and its approved team of specialized planners, to evaluate Daggett County's existing plans and to guide this process which is scheduled to take nine months. Aspen Rivers will work with a local team of interested residents and government officials to identify chapter elements either missing information or in need of update. In addition to this, and more importantly, this team will address a set of action statements for each effected chapter that describes what will need to be done to activate and initiate the plan. These plans are an outline and guidance to County officials as they will be making and adjusting the rules, laws, and ordinances that govern development and smart growth for Daggett County and Dutch John into the year 2030. It is not the intent to redo or ignore any prior work done in these areas over the years, but rather to create a new document that has greater implementation ability and a clearer path to develop a sustainable economy for the future of Daggett County and its residents. 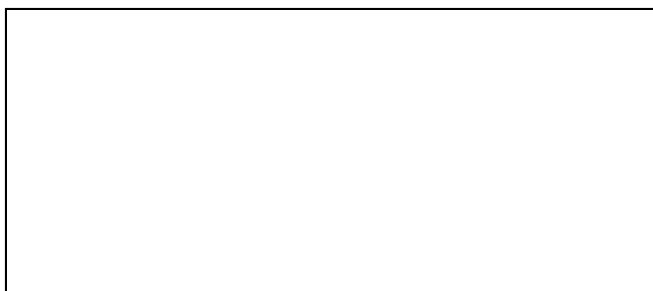
