

DAGGETT COUNTY RESOLUTION NO. 02-03

RESOLUTION ESTABLISHING DUTCH JOHN PRECINCT AND MANILA PRECINCT
JUSTICE COURT BOUNDARIES

WHEREAS, the Daggett County Commission has previously established boundaries for the Dutch John Precinct and the Manila Precinct Justice Courts.

WHEREAS, with the previous boundary established in 1996, two registered voters in the Dutch John Precinct are voting for retention of the Manila Justice Court Judge.

NOW THEREFORE BE IT RESOLVED BY THE COUNTY LEGISLATIVE BODY OF DAGGETT COUNTY THAT:

1. The boundary of the Dutch John Precinct Justice Court be as follows: All areas of land and water in Daggett County east of the east highway right-of-way of U.S. Highway 191 from the Daggett/Uintah County line to the Greendale Junction and all areas of land and water east and north of the north right-of-way of Highway 44 from Greendale Junction to Cub Creek and all areas east of Cub Creek from the east side of Cub Creek to the south boundary of the Flaming Gorge Reservoir, thence north across the lake, thence along the north and east boundary of Flaming Gorge Reservoir to the Wyoming border. See attached map for reference.

2. The boundary of the Manila Precinct Justice Court be as follows: All areas of land and water in Daggett County southwest of the northeast highway right-of-way of U.S. Highway 191 including U.S. Highway 191 from Daggett/Uintah County line to the Greendale Junction and areas west and south of the east right-of-way to Highway 44 from Greendale Junction to Cub Creek and all areas west of Cub Creek from the east side of Cub Creek to the south boundary of said reservoir, thence north across the lake, thence along the north and east boundary of Flaming Gorge Reservoir to the Wyoming border. See attached map for reference.

3. In the event of any ambiguities or discrepancies, jurisdiction shall be considered in the Manila Precinct.

This resolution shall take be effect immediately upon adoption and posting.

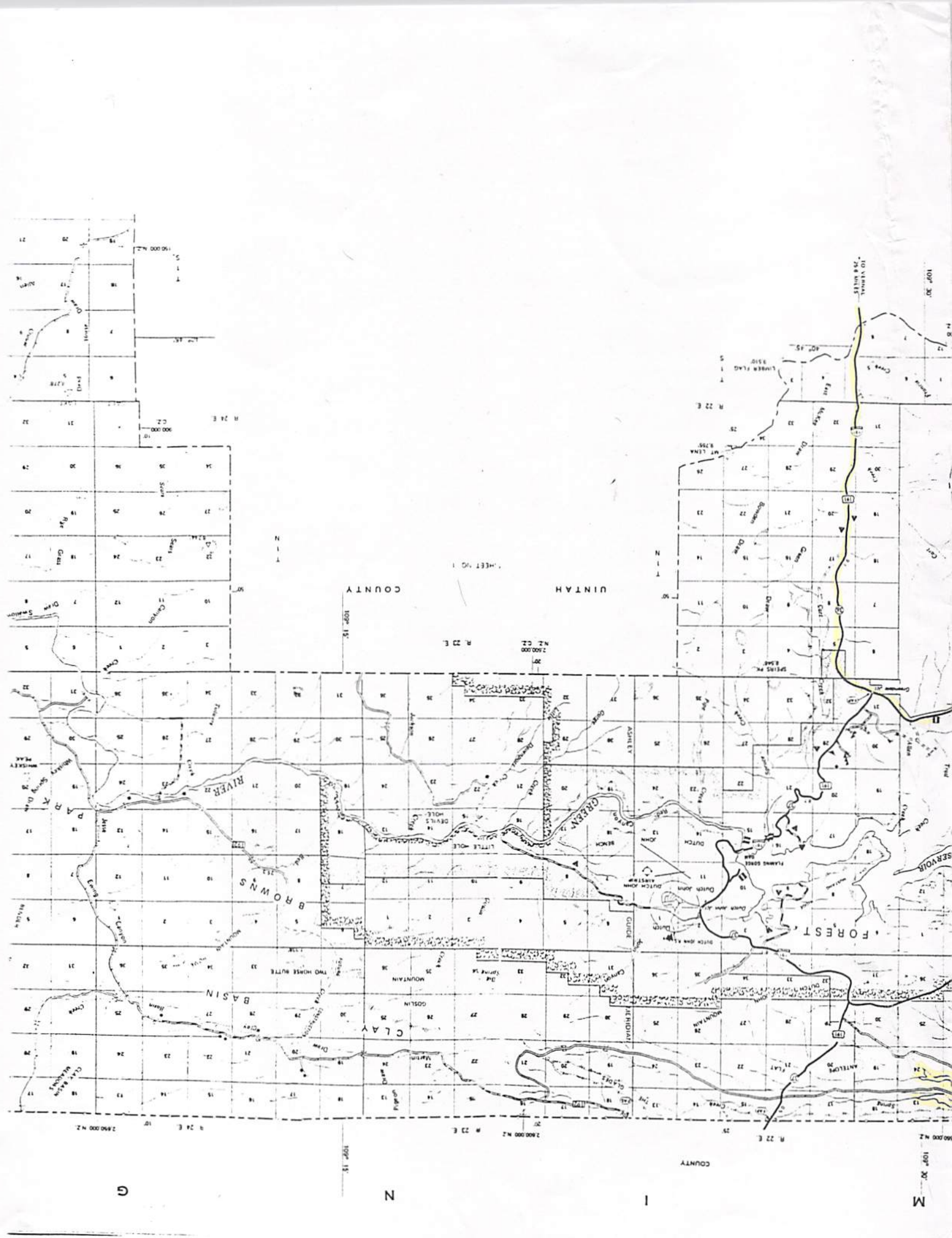

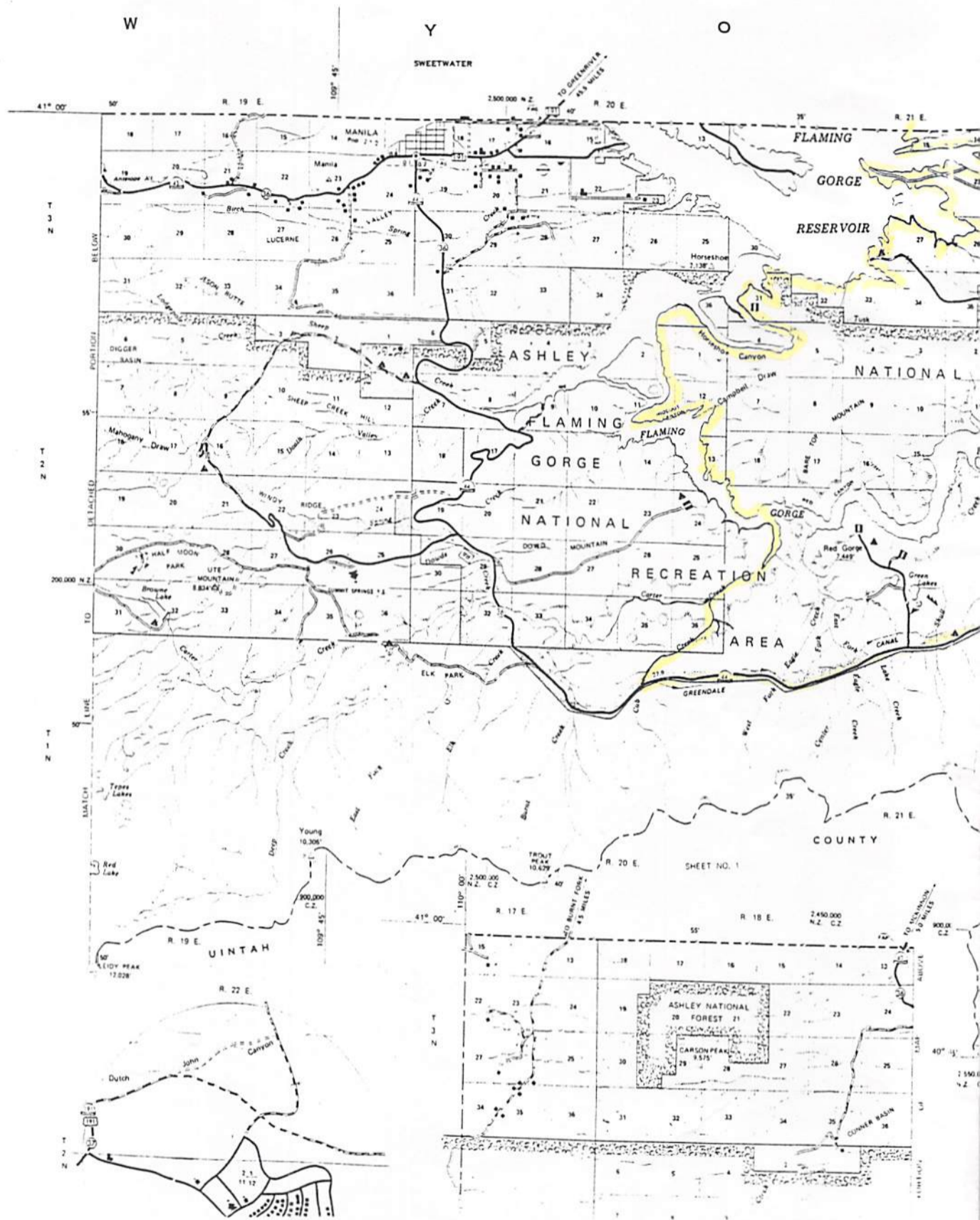
